

# END USER LICENSE AGREEMENT (EULA) for STAR FINANCE COMMAND CENTER™ TRIAL

**NOTICE:** BY DOWNLOADING AND INSTALLING, COPYING OR OTHERWISE USING THE SOFTWARE, YOU AGREE TO BE BOUND BY THE TERMS OF THIS EULA. IF YOU DO NOT AGREE TO THE TERMS OF THIS EULA, YOU MAY NOT DOWNLOAD, INSTALL, COPY OR USE THE SOFTWARE, OR IF YOU HAVE PREVIOUSLY DOWNLOADED THE SOFTWARE YOU SHOULD DESTROY IT AND ANY COPIES IMMEDIATELY. "YOU" MEANS THE NATURAL PERSON OR THE ENTITY THAT IS AGREEING TO BE BOUND BY THIS EULA, THEIR EMPLOYEES AND THIRD PARTY CONTRACTORS THAT PROVIDE SERVICES TO YOU. YOU SHALL BE LIABLE FOR ANY FAILURE BY SUCH EMPLOYEES AND THIRD PARTY CONTRACTORS TO COMPLY WITH THE TERMS OF THIS AGREEMENT.

## 1. DEFINITIONS

1.1 "**Software**" means software products that are licensed to you under this EULA, including, but not limited to, any related components purchased or provided with the Software, application programming interfaces, associated media, printed materials, online or electronic documentation, and any updates and maintenance releases thereto.

1.2 "**Software License Key**" means, if applicable, a serial number issued to you by Star Analytics to activate and use the Software. A separate, additional Software License Key may be required to activate and use each Licensed Additional Module.

1.3 "**Computer**" means a single physical computer containing a physical chip that houses no more than two (2) processor cores. Multiple computers that share processing power or operate in a networked configuration as a single logical computer, such as a "server farm" or similar arrangement, constitute multiple Computers for the purpose of this EULA.

## 2. EVALUATION LICENSES

2.1 **General.** If available, the Software may be activated with no-cost evaluation Software License Key(s). Evaluation Software License Keys have an expiration date ("Expiration Date").

2.2 **Evaluation License.** If you activate the Software or any Licensed Additional Module with an evaluation Software License Key ("Evaluation Product") you may use the Evaluation Product until the Expiration Date only to evaluate the suitability of the Evaluation Product for licensing on a for-fee basis. You may acquire evaluation Software License Key(s) for Licensed Additional Modules. In such case, the Licensed Additional Modules are licensed to you subject to the terms of this section.

2.3 **Evaluation Product Warranty Disclaimer.** During the use of the Evaluation Product, the limited 90-day warranty referenced in Section 7.1 below is not applicable to you. The Evaluation Product is provided to you "as is" without warranty of any kind, whether expressly implied, statutory, or otherwise. STAR ANALYTICS BEARS NO LIABILITY FOR ANY DAMAGES RESULTING FROM USE (OR ATTEMPTED USE) OF THE EVALUATION PRODUCT THROUGH AND AFTER THE EXPIRATION DATE.

2.4 **No Support.** Star Analytics has no duty to provide support to you during your use of the Evaluation Product, although support services may be provided at Star Analytics' sole discretion.

## 3. GRANT AND USE RIGHTS FOR SOFTWARE.

3.1 **License.** The Software is licensed, not sold. Subject to the terms of this EULA, Star Analytics hereby grants you a non-exclusive, non-transferable license, without rights to sublicense, to use the object code of the Software for the purpose as set forth in the applicable documentation for the Software and to the extent permitted by your payment of applicable license fees to Star Analytics and/or your Software License Key. Depending upon the edition of the Software licensed to you the Software License Key may limit your usage of the Software accordingly. You may use the documentation accompanying the Software in connection with permitted uses of the Software.

**3.2 License Limitations.** You may not copy the Software except for a reasonable number of machine readable copies of the Software for backup or archival purposes and except as expressly permitted in this EULA. You may not remove any titles, trademarks or trade names, copyright notices, legends, or other proprietary markings on the Software. You are not granted any rights to any trademarks or service marks of Star Analytics. Star Analytics retains all rights not expressly granted to you.

**3.3 Distribution.** You may distribute the Software internally within your entity provided that (i) you do not modify the Software; (ii) you do not distribute the Software to any third party; (iii) you agree to indemnify, hold harmless, and defend Star Analytics from and against any claims or lawsuits, including attorneys' fees, that arise or result from the use or distribution of the Software.

**3.4 Restrictions.** You may not (i) sell, lease, license, sublicense, distribute or otherwise transfer in whole or in part the Software or the Software License Key to another party; (ii) provide, disclose, divulge or make available to, or permit use of the Software in whole or in part by, any third party (except Designated Administrative Access) without Star Analytics' prior written consent; or (iii) modify or create derivative works based upon the Software. Except to the extent expressly permitted by applicable law, and to the extent that Star Analytics is not permitted by that applicable law to exclude or limit the following rights, you may not decompile, disassemble, reverse engineer, or otherwise attempt to derive source code from the Software, in whole or in part. You may use the Software to conduct internal performance testing and benchmarking studies, the results of which you (and not unauthorized third parties) may publish or publicly disseminate; provided that Star Analytics has reviewed and approved of the methodology, assumptions and other parameters of the study.

**3.5 Upgrades.** If you wish to use additional features of Star Finance Command Center which are not enabled in the Trial Edition you may upgrade the Software to a different edition of Star Finance Command Center. To upgrade the Software you should contact Star Analytics or an authorized distributor, reseller or agent who is licensed to resell the Software in your territory. You may also be required to first pay an additional license fee and to sign a specific Software License Agreement or other agreements with Star Analytics in order to obtain an appropriate new license key. If you do so those agreements will supersede this EULA.

**4. TITLE.** Star Analytics retains all right, title, and interest in and to the Software and the Software License Key and in all related copyrights, trade secrets, patents, trademarks, and any other intellectual and industrial property and proprietary rights, including registrations, applications, renewals, and extensions of such rights.

## **5. SUPPORT AND MAINTENANCE SERVICES**

**5.1 Support Services.** Star Analytics will only provide the following support services under this EULA:

- a) Web browser access to the Star Analytics support portal and knowledge base, currently available at [www.staranalytics.com/support](http://www.staranalytics.com/support).
- b) Limited email support via the Star Analytics web site for a period of 90 days from the date you registered the Software. Such email support shall only be provided to users of the Software who register and obtain a valid license key as described herein. Star does not guarantee to respond to emails requesting support services for the Star Finance Command Center Trial Edition in less than two business days from the receipt of such emails. **5.2 Maintenance.** This EULA does not give you any rights to any maintenance services from Star Analytics, including updates or upgrades to the Software or any extensions or enhancements to the Software developed by Star Analytics at any time in the future. Star Analytics may offer support and/or maintenance services separately for an additional fee. Any supplemental software code or related materials that Star Analytics provides to you as part of any support and subscription services are to be considered part of the Software and are subject to the terms and conditions of this EULA. Star Analytics may use any technical information you provide to Star Analytics for any Star Analytics business purposes without restriction, including for product support and development. Star Analytics will not use such information in a form that personally identifies you.

**5.2 Limitation/Termination.** Star Analytics may limit or terminate the support and maintenance services provided under this EULA without prior notice.

## **6. TERMINATION**

**6.1 Termination.** Star Analytics may terminate this EULA immediately and without notice if you fail to comply with any term of this EULA.

**6.2 Effect of Termination.** In the event of termination, you must destroy all copies of the Software and Software License Key. In addition you must remove all copies of the Software, including all backup copies, from the Server and all Computers on which it is installed. From time to time, Star Analytics may change the terms of this EULA. Star Analytics will notify you of such change. Your continued use of the Software will indicate your agreement to the change.

## **7. LIMITED WARRANTY AND LIMITATION OF LIABILITY**

**7.1 Limited Warranty.** Star Analytics warrants that the media, if any, on which the Software is delivered will be free of defects and that the Software will substantially conform to the description contained in the applicable end user documentation in each case for a period of 90 days after the date of shipment of the Software License Key.
